

Willunga High School 1 to 1 Laptop User Agreement



Before being issued with a Willunga High School laptop students and parents must carefully read both the 1 to 1 Laptop Handbook and the 1 to 1 Laptop User Agreement, understand the contents, and sign and return this laptop user agreement to the school.

It is important to keep a copy of the 1 to 1 Agreement for future reference.

Student agreement

My responsibilities are:

- reading and understanding the responsibilities outlined in the 1 to 1 laptop program handbook
- following the cyber safety strategies outlined in the 1 to 1 laptop handbook to maintain a cyber-safe environment
- accepting all policies and guidelines as per Willunga High School's positive behaviours for learning policy
- taking proper care of the laptop as outlined in the 1 to 1 laptop handbook
- understanding that if the laptop has been damaged, lost or stolen I and/or my parent/legal guardian may be responsible for the cost of repairs or replacement
- understanding that failure to comply with the 1 to 1 laptop agreement will result in the loss of access to the laptop for home use.

Parent/legal guardian agreement

My responsibilities are:

- reading and understanding the 1 to 1 laptop user agreement carefully and discussing the contents with my child, ensuring we are both clear of the contracts guidelines
- being aware of the cyber safety strategies for parents outlined in the 1 to 1 laptop handbook and encouraging my child to be cyber-safe
- acknowledging that if my child leaves Willunga High School the laptop must be returned to the school or the balance owing must be paid in full to retain ownership
- agreeing to pay \$400 per year for each of the three years stated for my child to access the 1 to 1 laptop program (please see reverse side for payment options)
- agreeing to pay the \$100 excess if the laptop is damaged and requires repair using accidental damage cover.
