Context Statement

Willunga High School caters for students from 7-12. At the time of this report, the enrolment in 2024 is 706. Willunga High School is classified as Category 5 on the Department for Education Index of Educational Disadvantage. At the time of this report, the school population includes 4% Aboriginal students, 35% students with disabilities, 4% children/young people in care. - Reviewing and reflecting on the school improvement data

In 2025 the governing councils work will continue to support the school's operations and improvement agenda.

- Ongoing review of school uniform continuing to seek student feedback regarding the options available to students while still adhering to the recently reviewed uniform policy.
- Review of house structure and names
- Review and set Materials & Services charges for 2025
- Ongoing review and reflection of the improvement progress the school is making alongside the our alignment with the Strategy for Public Education in South Australia
- Involvement in establishing a new WHS Strategic Directions, for the next 5 years, to replace the 2021 2026 directions.

Future activities of the Governing Council will reflect the ongoing challenges that result from changes in the school population due to the opening of the Aldinga school, ongoing advocacy for improvements in the school facilities and infrastructure and supporting the operations of the school to improve our students and family's educational experiences.

The Governing Council is open to all parents of Willunga High School students and there is no requirement to hold an elected position. Parents, students and members of the community are invited to attend any meeting of the Governing Council and contribute to their school community.


I would like to thank all members of the 2024 Governing Council for their dedication to the role, for their support of the school leadership, staff and students of Willunga High School.


Performance Summary NAPLAN Proficiency



Attendance Comment

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
